MEMBER NEWS!


We warmly welcome a brand new TCARA member and a great license upgrade:

Congratulations to member Maribel Gershman KN6HSW for notching her General Class upgrade in February. Maribel hit the bulls-eye on her first shot and we know she's starting to look around for an HF radio and places to plant nice pieces of aluminum and wire! Be sure and water them and we are sure they will grow. Congratulations Maribel.

Tim Adams, N6DLC made some interesting discoveries about power ratings on the 9:1 UNUN's commonly used with the popular end-fed non-resonant antennas. Turns out that some manufacturers might be a little generous with power ratings, focusing on low duty cycle capability such as SSB or CW. When using these devices on high duty cycle modes like FT8 or RTTY (and especially if the SWR is a bit high) they can heat up and the ferrite cores lose their properties. The SWR can avalanche at the radio and the protection circuits fold back the power. So if you are seeing erratic power levels or SWR levels you may have a damaged UNUN. And if you are buying a new one, move up a size or two, especially for digital modes. Helping another ham, Tim found one popular unit rated at 500W that had apparently been damaged by a 100W radio.

AMATEUR RADIO NEWS HIGHLIGHTS AND ANNOUNCEMENTS

The QSOTODAY Virtual Ham Radio Expo is returning this year on **March 13th and 14th**. There is a modest registration fee this year, which is reduced if you register early. It sounds like an even larger speaker and presentation list than last year. Details are found at their website at **www.qsotodayhamexpo.com**

Reminder – Free Online Editions of Four ARRL Magazines (for ARRL Members): During the past year (April 2020) the ARRL has relaxed access to some of the previous subscription-only publications for ARRL members. If you are an ARRL member you can access issues of QST and the recently introduced ON THE AIR magazine for new hams. Plus you have access to QEX, the forum for communications experimenters (previously a somewhat costly subscription) as well as NCJ the National Contest Journal. You can find links to these (once logged in to ARRL) at this link: www.arrl.org/arrl-magazines. Enjoy some interesting browsing of articles, old and new!

HF Propagation: After a fairly quiet couple of months we saw sunspot numbers kick up a bit towards the end of February and a nice little uptick in the solar flux index lifting us out of the low 70's and up into the 80's for a good period. Offsetting this on some days was some geomagnetic activity. But over all we saw activity not present since the spurt of activity late last year. Here's hoping we see MORE as Cycle 25 develops!

2021 Field Day Rules Waiver!!!: You may recall that during 2020, due to the pandemic, the ARRL took the unusual step of altering the Field Day rules to permit class D home stations to earn points from contacts with each other and with other classes of Field Day stations – and further – to allocate those points (if desired) to a specific ham radio club so that such clubs could amass a consolidated score from members operating from home in order to maintain safe social distancing in difficult times. (Normally Class D stations can only count points for contacts with Classes A, B, C, E and F – not other Class D's, but that was waived for 2020 and now for 2021). **The ARRL recently announced an extension to this rule waiver for Field Day 2021**, but this year has added a restriction for both class D and E (home station with emergency power) limiting such stations to 150 Watts PEP. Last year's rule waiver resulted in a huge level of active on-the-air participation during Field Day and it is to be hoped that we see this again in 2021! An early announcement was made to make it easier for participants to plan ahead.

Former ARRL Southwestern Division Director Art Goddard, W6XD, SK. Art was an active participant in the ARRL SW division including two terms as Vice Director before becoming director in 2001. General Meeting Minutes – Feb 10, 2021, 7:00PM

- I. Call to Order at 7PM. Minutes of last month's meeting approved by general consent.
- II. Approval of Minutes of General Meeting of Jan 13, 2021 as sent via QRM
- III. Secretary's Report Dave Wilkie K6EV. We have 45 paid members plus 3 licensed family members for 48 total. Of these 24 are Extras, 1 holds an Advanced, 15 are Generals and 8 are Technicians. 1 more pending.
- IV. Program Director: Tim Adams N6DLC. Program for today: Field Day decisions AND Quartz-Pause report.
- V. Publicity Report Ken Mixon KC6WOK. New club website has grown greatly. Looking at adding CW training.
- VI. Old Business: Follow-up answers to member questions from January's session on Remote Testing via Dave K6EV and thanks to Shaun K6CT. Individual W5YI teams accept different forms of payment. Shaun's team accepts Paypal, Venmo and Zelle. Credit cards MIGHT be possible via Paypal. Candidates who pass the first test and wish to test another level up are interviewed as to whether they have really studied and are ready as examiners time is valuable and others are waiting. If not ready they are discouraged from further testing on that date. Examinees who fail a text by only one or two questions may be permitted to re-test for a repeat fee, but not if they missed a significant number of questions again because other candidates are waiting.
- VII. Treasurer's Report Ken Barto N2HL. Balances are 4513.58 plus 200 cash for a total of \$4713.58 VIII. New Business: TCARA 2021 Field Day, Kurt Dodge Chairperson.
 - a. Discussion of Issues: Many highly active members with dual club membership are already committed to another field day plan underway for some months. Some other members are out of town. Pandemic conditions are unpredictable. TCARA members are welcome at the GOTAhams site as a backup option. Marida and Maribel observed that site must be interesting and larger sites are attractive. Ken Mixon observed that the pandemic presents risks to the GOTAhams site plan also and that it is impossible to be certain of outcomes he recommended planning for best case, mid case and worst case. Dave reminded the group that ARRL today announced extension of the 2020 class 1D waiver to permit home stations to fully participate, albeit with a 150 watt power limit. Ken Barto observed that there are new hams at the PV Hospital, PVH is keenly interested in engaging them and us and that PVH probably offers radios, masts, generator, antennas, infrastructure including a mobile truck and possibly even a site.
 - b. In addition to Kurt, the following club members agreed to participate in a planning committee meeting to be organized by Kurt; Bruce Bolton, Ken Barto, Tim Adams and Dave Wilkie. The group will further discuss the issues and formulate recommendations. Kurt was thanked for taking on the tough job of raising the issues, thanks to all for their open and candid participation in the discussion.
- IX. New Member Welcome: Shawn Brunel of La Verne, KN6CZP is in the process of joining us. WELCOME!
- X. General Announcements: Hamvention 2021 is cancelled but registrations are underway at qsotodayhamexpo.com for virtual hamfest on March 13, 14. Sunday night net 7PM on 446.400 (-) PL 103.5. Join us for Zoom at Noon every Saturday! Nightly nets with our sister club GOTAhams every night at 8.
- XI. Bruce noted and thanked the members for the great meeting turnout we had 25 in attendance.
- XII. Presentation: Recap of events at this year's Quartz-Pause (QuartzFest paused during Pandemic) near Quartzite Arizona Ken Mixon. A great ham social event and a challenging radio operating environment. Ken brought extensive photos that were interesting to those who could not attend.


Field Day:

The club generally plans and executes a Field Day operating plan at a site and in a configuration developed by the members. ARRL Field Day is Amateur Radio's signature annual operating event and is a lot of fun. Field day occurs on the last full week-end of June. Planning generally begins in the fall and winter of the previous year.

Amateur Radio License Testing

TCARA members offer ARRL VEC testing that provides license examinations for all classes of Amateur Radio License (Technician, General and Extra). Testing is generally on the last Saturday of each month and is at 1PM. The testing location is held at the Bracket Field Airport Administration Building, 1615 McKinley Avenue, La Verne, CA. 91750. (The same building that holds 'Norms Hangar' coffee shop). While walk-ins are usually accepted, we recommend that you contact Mr. Frank C. Westphal in advance and advise him of what license level you will be testing for. You may contact Frank by email at k6fw1@verizon.net or by phone at (909) 257-7205. Frank will advise you as to what to bring or not to bring to the testing session. Testing fee is \$15.00. TCARA members are also available to help you as you study for your license. To date, testing sessions have been suspended during the pandemic. Contact the club or an officer for information about other remote test sessions that may be available to you on-line. Testing is available for either new licensees or upgrades.
