### AMATEUR RADIO NEWS HIGHLIGHTS AND ANNOUNCEMENTS

The Annual Armed Forces Cross-Band Test began yesterday and continues thru today, May 8<sup>th</sup>, in recognition of Armed Forces Day on May 15<sup>th</sup>. This unique test is authorized under FCC part 97 rules. Military stations transmit on military frequencies and Amateur stations transmit on Amateur frequencies. The FCC's revised rules on RF Exposure took effect last week on May 3<sup>rd</sup>. While RF exposure limits are unchanged, all stations are now required to go through the evaluation process. Existing stations that are unchanged have a 2 year grace period. Stations that install changes that would affect RF exposure (new antennas, power changes, band changes, etc.) must perform an analysis immediately. The process is not as difficult as you may believe and resources are found at the ARRL website at: <a href="http://www.arrl.org/rf-exposure">http://www.arrl.org/rf-exposure</a> Other club members may also be available to assist you. Ask for help if needed!

Starting May 20<sup>th</sup>, all FIRST TIME EXAM APPLICANTS MUST OBTAIN AN FCC "FRN" NUMBER BEFORE TAKING THE EXAM. Candidates already licensed already have an FRN number assigned and should use that number. For those of you who are ARRL members, remember that QST is viewable online via the ARRL website. Consider adding the QST apps for Android, iOS or Kindle available at the Google Play, Apple App Store and Amazon respectively. A huge archive of past issues is also available, including a tremendous number of product reviews and great technical and historical material. If you are not a member of ARRL, consider joining. Support the great work they do in keeping us informed and engaged. You can also find online access to ON THE AIR and QEX magazines, as well as the National Contest Journal (NCJ).

**The \$35 Amateur Radio Application Fee** is coming later this year! The FCC expects to begin collecting the fee later this year when all of its processes and procedures are updated.

**HF Propagation:** Cycle 25 has not really taken off yet. We are having some up's and downs, but noting rising to what we had late that year. Hopefully we'll shake off the doldrums soon! That said, DX is still possible, so don't let it stop you from getting on the air!

**2021 Field Day Rules Waiver!!!:** Recall that during 2020, due to the pandemic, the ARRL took modified Field Day rules to permit class D home stations to earn points from contacts with each other and with other classes of Field Day stations and to allocate those points (if desired) to a specific ham radio club. **The ARRL recently announced an extension of this rule waiver for Field Day 2021**, but restricting class D and E (home station with emergency power) to 150 Watts PEP.

# **General Meeting Minutes – April 14, 2021, 7:00PM**

- I. Call to Order at 7:03PM via Zoom video conference and President's Report:
  - a. March 24<sup>th</sup> Passing of Bob Embry, KD6DKV, long time TCARA Health & Welfare Director.
  - b. With the Pomona Valley hospital cooperation and site taking the spotlight for this year's TCARA Field Day operations, Ken Barto (who has a close relationship with the hospital communications team) has agreed to take over the lead role in guiding this year's Field Day effort.
- II. Secretary's Report:
  - a. We have 46 members plus 3 licensed family members for 49 total.
  - b. Minutes of last month's meeting as published in QRM. Approved by general consent.
  - c. We continue to seek any old copies of QRM, club photos, etc. as we re-develop a club archive. Also, any inputs and member news for QRM are helpful.
  - d. At tonight's meeting we will present the proposed by-laws revisions.
- III. Program Director: Tim Adams N6DLC. Program for today: Radio Teletype Software and Mechanical Radio Teletype Operation: Dan Jones K6YIC.
- IV. Publicity Report Ken Mixon KC6WOK. We continue to add additional content to the website.
- V. Treasurer's Report Ken Barto N2HL. Funds balance is \$4747.09 inclusive of \$200 petty cash. We have no due bills on hand and are exploring the most cost efficient means of renewing the club's liability insurance (ARRL?). Motion to accept the report by Dave, K6EV. Second by Ken Mixon KC6WOK. Approved unanimously.
- VI. General Announcements: Reminder that, for the time being, our weekly net has moved to the AE6TV repeater at 449.160 (-5Mhz offset) PL = 77.0 Hz. The WA6FZH repeater is down. Our thanks to Hans, AE6TV!
- VII. Moving Saturday's Zoom chat session from 'Zoom at Noon' to 'Talk at Ten' has not been a great success. Bruce asked if there was any objection to moving it to 11 AM and there were no objections raised.
- VIII. Presentation: Proposed changes to TCARA bylaws Dave Wilkie K6EV Dave reviewed the rationale behind the proposed changes and confirmed that copies would be mailed to members for consideration immediately. A vote to approve the changes as a total package will be held at the May meeting, in keeping with the modification procedure defined in the existing bylaws. In order to not delay our RTTY presentation we deferred most discussion till next month, by which time members will have had a chance to read thru the proposed bylaws. Our thanks to the committee members, club members and board members who invested a huge amount of time in the operational review preceding the proposal and in the editing/reviewing of the changes. The changes were also announced in the April issue of QRM and the announcement will be repeated in the May issue.
- IX. Presentation: Software and Mechanical Radio Teletype Operation Dan Jones K6YIC. Dan gave a great overview of his station comprising vintage U.S. Navy derived radio Teletype equipment which included videos of the pieces of mechanical teletype in operation composing and transmitting messages. He also gave comparisons to RTTY operation using simply software on your PC with a suitable radio (FLDIGI etc). Dan also gave an overview of some of the history of the mode as well as the different mark/space frequencies and baud rates that have been employed in military and civilian RTTY. And, just as an extra, we got to see some photos of the radio room of the U.S.S. Iowa Battleship shipboard museum where Dan volunteers. This was really enjoyable presentation and THANK YOU DAN.


### Field Day:

The club generally plans and executes a Field Day operating plan at a site and in a configuration developed by the members. ARRL Field Day is Amateur Radio's signature annual operating event and is a lot of fun. Field day occurs on the last full week-end of June. Planning generally begins in the fall and winter of the previous year.

### **Amateur Radio License Testing**

TCARA members offer ARRL VEC testing that provides license examinations for all classes of Amateur Radio License (Technician, General and Extra). Testing is generally on the last Saturday of each month and is at 1PM. The testing location is held at the Bracket Field Airport Administration Building, 1615 McKinley Avenue, La Verne, CA. 91750. (The same building that holds 'Norms Hangar' coffee shop). While walk-ins are usually accepted, we recommend that you contact Mr. Frank C. Westphal in advance and advise him of what license level you will be testing for.
